The functionality criteria consist of: Experience applicable to last 5 years, Locality, Experience of Key Personnel and available plant • Original certified copy of Registration certificate of the relevant service • Late bids will not be accepted • This tender will be valid for a period of 90 days after the closing date • This tender must only be submitted on the documentation provided by Abaqulusi Municipality (Original document) • An original Certified current account in terms of water and electricity / rates and taxes obtainable from your local municipality must be submitted not older than three months or lease agreement • Certified copies of identity documents of directors and owners of the company must be submitted • Failure to comply with these minimum requirements will result in immediate disqualification of the bid.
